- Provide a certified cheque issued from bank licensed to operate in Kuwait for the Kuwait Authority for Partnership Projects with sum of ten thousand Kuwaiti Dinars (10,000 KWD) in the name of “Kuwait Authority For Partnership Projects” (non-refundable).

Required Documents:

 - Final financial studies.
 - Financial Documents should be separate from Technical Documents.
 - Submitting 2 hard copies of each study + 1 CD.
